

# **RULES FOR ACCOMMODATION OF STUDENTS AND EMPLOYEES OF BUT IN THE DORMITORIES OF VUT IN BRNO IN THE ACADEMIC YEAR 2024/25**

## **ARTICLE 1**

### **STUDENT ACCOMMODATION**

#### **1. Persons to whom accommodation is provided according to this decision**

Accommodation is provided to BUT students who:

- are studying full-time, and for students studying at BUT as part of mobility programs,
- have settled the obligations related to accommodation towards the dormitories and canteens of BUT as of the date of signing the accommodation contract.

#### **2. Accommodation of foreign students studying full-time as part of mobility programs (Erasmus+, CEEPUS, Aktion, etc.) and foreign students studying in Czech study programs (does not apply to students from the Slovak Republic)**

The above-mentioned students submit their applications electronically at [www.kam.vutbr.cz](http://www.kam.vutbr.cz), where there are instructions for submitting applications in the English version. The application deadline for the winter semester of the academic year 2024/25 is from 25. 3. 2024 and for the summer semester from 16. 8. 2024.

#### **3. Accommodation of students-foreign nationals studying full-time in the Czech or English language and living in dormitories (does not apply to students from the Slovak Republic)**

These students make a reservation in person at the office of the Accommodation Department (Building A03, 2nd floor, door 028). At the same time, a reservation fee of CZK 2,000 is paid.

- date 4. 3. 2024 to 22. 3. 2024 for students who do not want to change rooms and had an accommodation contract concluded in academic year 23/24
- date 23. 3. to 31. 3. 2024 for partner couples (who do not have a reservation for existing rooms),
- date 1. 4. to 17. 4. 2024 for students who want to change rooms and had an accommodation contract concluded in academic year 23/24

#### **4. Accommodation of students as part of Summer accommodation**

Students requesting summer accommodation in the dormitories between 30. 6. and 1. 9. 2024 can make a reservation as follows:

- Deadline 13. 5. to 26. 5. 2024 – submission of application in electronic form for students already living in dormitories.
- Date 27. 5. to 31. 8. 2024 – securing a reservation in person at the office of the Accommodation Department (Building A03, 2nd floor, door 028) for students who do not live in the dormitories.

## **ARTICLE 2**

### **EMPLOYEEYS ACCOMMODATION**

**BUT** employees are entitled to request accommodation, which will be provided to them if the capacity of the university dormitories allows it. Accommodation conditions are agreed upon by the employees:

- Electronically only for employees already resident in the period 9. 4. to 17. 4. 2024
- in person at the office of the Accommodation Department (building A03, 2nd floor, door 028) at the deadline 19. 4. to 29. 4. 2024.
