**DIRECTOR'S DECISION NO. 1/2026**  
**RULES FOR ACCOMMODATION OF STUDENTS AND EMPLOYEES OF BUT IN THE**  
**DORMITORIES OF BUT IN BRNO IN THE ACADEMIC YEAR OF 2026/27**

**Article 1**

**Student accommodation**

**1. Persons to whom accommodation is provided according to this decision**

Accommodation is provided to BUT students who:

- are studying full-time and for students studying at BUT as part of mobility programs,
- have settled the obligations related to accommodation towards the Halls of Residence and Dining Services as of the date of signing the accommodation contract

**2. Accommodation of foreign students studying full-time as part of mobility programs (Erasmus +, CEEPUS, Aktion, etc.) and foreign students studying in Czech study programs (does not apply to students from the Slovak Republic)**

- a) The above-mentioned students newly enrolled to BUT university submit their applications electronically at [www.kam.vutbr.cz](http://www.kam.vutbr.cz) where there are instructions for submitting applications in the English version. The applications for the winter semester will be available from 23.3. and for the summer semester from 17. 8. 2026.
- b) The above-mentioned students already resident at the BUT dormitory in the 2025/26 academic year will conclude a new accommodation contract in person at the office of the Accommodation Department (Building A03, 2nd floor, door 028). At the same time, a reservation fee of CZK 5,000 is paid.
  - 2. 3. -20. 3. 2026 – a term for students to reserve their current room
  - 23. 3. -27. 3. – a term for partner couples (who do not have a reservation of their current rooms)
  - 30. 3. -17. 4. – a term for students who intend to change rooms

### **3. Accommodation of students as part of summer accommodation**

Students requesting summer accommodation in the dormitories between 30. 6. and 7. 9. 2026 can make a reservation as follows:

- 11. 5. -25. 5. 2026 – a term for securing a reservation in person at the office of the Accommodation Department (Building A03, 2<sup>nd</sup> floor, door 028) for students already resident at the dormitories
- 27. 5. -31. 8. 2026 – a term for securing a reservation in person at the office of the Accommodation Department (Building A03, 2<sup>nd</sup> floor, door 028) for students not resident at the dormitories

#### **Article 2**

#### **Employee accommodation**

1. BUT employees are entitled to request accommodation, which will be provided to them with regard to available capacity.
2. Accommodation conditions are agreed upon by the employees:
  - In person at the office of the Accommodation Department only for employees already resident in the period from 13. 4. to 20. 4. 2026
  - In person at the office of the Accommodation Department (Building A03, 2<sup>nd</sup> floor, door 028) in the period from 22. 4. to 29. 4. 2026
